Mr. McCutcheon explained that a year ago the snow storm collapsed the back wall of the civic center and also did extensive damage to the annex. He explained the annex is back in operation. He said staff has been in long standing negotiations with the Insurance Company over what returning the civic center to a workable condition would mean. He said the City has contracted with Durham Mackay to put together an architect's proposal. He explained the proposal is ready to go out to bid and based on the bids received, the City will settle on an amount with the insurance company.

Councilor Doporto asked if the bid is over the \$700,000, will the insurance still reimburse the City. **Mr. McCutcheon** answered yes, that is the agreement.
