Sandy Gonzalez presented the 1st Quarter Financial Statement for both the Non-Promotional and Promotional Lodgers Tax Fund for the Fiscal Year 2017 – 2018.

- A) Non-Promotional Fund
 - > Total Revenues to Date: \$435,301.25
 - > Total Expenditures to Date: \$218,627
 - > Excess Revenue to Date: \$216,674.66
 - > Ending Cash Balance: \$978,499.77
- B) Promotional Fund
 - > Total Revenues to Date: \$290,200.84
 - > Total Expenditures to Date: \$49,562.82
 - > Excess Revenue to Date: \$240,638.02
 - > Ending Cash Balance: \$1,769,430.82
