0:00:45 **2. CONSIDER APPROVAL TO APPOINT JANELL E. WHITLOCK AS THE MUNICIPAL JUDGE FOR THE CITY OF CARLSBAD**

Mayor Janway explained Municipal Judge Janet Ellis recently announced her resignation from her elected position. He said the city appreciates Judge Ellis' dedication and are deeply sorry to see her go. He said in January Janell Whitlock

stepped down from her position on City Council to fill in as Municipal Judge, a position she has filled most capably. **Mayor Janway** said he is honored to recommend Janell Whitlock's full appointment to the position of Municipal Judge to serve out Judge Ellis' term until the next regular municipal election.

Mayor Janway gave a recap of Janell Whitlock's accomplishments. He said Janell was married to the late Senator Louis Whitlock; she has five daughters, 13 grandchildren, and 20 great grandchildren. He explained Janell began with the Chamber of Commerce in 1968 and has worked with the Potash Industry, the City of Carlsbad, and has been a business owner. He explained her public service career began as a court administrator leading to her 18.5 year position as Municipal Court Judge. He said Ms. Whitlock retired and was elected to the County Commission for 4 years and then became Director of Retirement for the Chamber of Commerce, and served on the City Council. He said Janell Whitlock has been President of the New Mexico Municipal Judge's Association, President of the New Mexico Court Clerk's Association and Vice President of the Carlsbad Community Foundation. He explained Ms. Whitlock has led the recent effort to see Carlsbad certified as an Age Friendly Community. He said Ms. Whitlock has received the New Mexico Outstanding Woman of the Year Award, the Elks Distinguished Citizen of the Year, and the Eddy County Bar Association Liberty Bell. He said none of that comes close to capturing Janell Whitlock, who always goes the extra mile in every effort she puts forth.

Mayor Janway said the citizens of Carlsbad deserve a Municipal Judge who will lead with dignity and wisdom and there is no better choice than Janell Whitlock.
