#### ITEM 5 - Report from City Arborist

Luis Renteria said three cottonwood trees were removed from Lake Carlsbad east of the water park, and two trees were removed from Riverside Country Club due to splitting in half. The oak trees have been trimmed at the rocket slide area and the mulberry trees have been removed at the tennis courts. Luis said the quote for tree trimming at the beach area will be about \$16,000. Ken asked if the \$16,000 was going to come out of the maintenance budget. Luis said no they are going to come up with funding, and do a budget adjustment.

Luis mentioned that the Board needs to decide where to have the Arbor Day Celebration. Ken said there are trees at Arcadia Park and 5<sup>th</sup> Street Park that need to be removed and replaced. Dave Rogers mentioned that the cotton wood trees at the Pavilion's by River Bend look very good. Ken suggested planting two redbud trees at Halagueno Park. Lupe's Crew removed- the dead trees that were in front of the Federal Building Annex in the planters. Ken said new shade structures would also be installed at Troy Young Park, Smith Park, 8<sup>th</sup> Street Park and at the entrance of the water park. Ken asked the Board to go by Arcadia Park, 5<sup>th</sup> Street Park, and Dr. Martin Luther King Jr. Park for tree planting suggestions keeping in mind that irrigation is critical.
