4. Discuss upcoming events: HHW/Rx Takeback Day & Tarp Giveaway Day @ Sandpoint Landfill:

She also stated that she and Eddy County Landfill Manager Fabian Gomez have coordinated a day to give out tarps to those who show up at the Sandpoint Landfill on Friday, November 1, 2019 with uncovered loads with a reminder to begin covering loads in an education and outreach effort.

5. Carlsbad Clean-Up Task Force Update:

Mary Garwood stated that the recycling committee of the Carlsbad Clean-Up Task Force took a trip to Lea County to visit their recycling and solid waste convenience drop-off station and that it was a very educational for the group. She also stated that she and Chairman Dave Sepich would be soon talking with the Carlsbad Current Argus regarding the introduction of the single-use plastic bag ban ordinance that was recently presented to Mayor Dale Janway and City of Carlsbad Administration. Regarding a discussion about uncovered loads, Joshua Calder presented the group with State Statute 66-7-407 which prohibits uncovered loads in transport. Mary Garwood stated she would forward this information to Mr. Sepich for review and consideration.
