## 1. Roll Call and Determination of Quorum

## 3. Approval of Minutes of the Board of Water and Sewer Commissioners Regular Meeting held June 16, 2022

- 4. Utilities Department Monthly Reports and Project Updates presented by Ivan Abell M. Abell reported for the month of June 975 acre feet of water was pumped from Sheep Draw, which is more than last year at this time. Approximately 115 acre feet was pumped from Double Eagle, and delivered to the city about 64 acre feet. He reported the Wastewater Treatment plant treated approximately 13 to 14 acre feet and had about 473 gallons of septage. They also delivered about 82 acre-feet of effluent to the Golf Course.
- J. Lowe asked how many wells were operational at Sheep's Draw. M. Abell reported there are nine operational wells. J. Lowe asked if the Transducer has been installed and calibrated. M. Abell stated that is correct.
- J. Lowe asked for a report on the rain gauge. R. Myers reported no rain. J. Lowe mentioned there is a rain gauge at Sheep's Draw that ties into a computer that prints out the rain in that area.
- J. Lowe stated next month they will provide a report on Capital Projects.

### 5. Financial Reports presented by Melissa Salcido

M. Salcido gave a summary of the June Financials. Revenues are unfavorable to the budget. This is due to grants for projects that the city hasn't been reimbursed. Costs for labor are favorable to the budget, operating costs are favorable to the budget and capital costs are favorable to the budget.
