He mentioned Soccer league started on October 12, 2021 and ends November 18, 2021. Soccer has forty-nine teams with eight divisions. He also reported Flag football started on October 09, 2021 and ends November 13, 2021. Flag football has 28 teams participating. Practices for travel baseball and softball teams continue at BFYSC.

6. Update on Tournaments

There is a USSSA Softball tournament scheduled for November 13-14, 2021. The 3v3 Live Soccer Tournament on July 24, 2021 had sixty-three teams and the next tournament will be November 13, 2021. USSSA Baseball (Director- Tommy Hawkins) has a tournament scheduled for December 11-12, 2021.

7. Update on Capital Projects

Soccer field merge and over seeding was completed at the beginning of August. The soccer fields were closed because of the over seeding of soccer from August 06, 2021 until October 09, 2021. The soccer fields look outstanding- Accent Landscaping did a great job. The digital sign in front of the Sports Complex is installed and operating.

9. Discussion and Update on BFYSC Scheduled Events and Activities
