- General Fund Information Tech Increase Capital \$6,000.00 for security cameras at Heritage Park.
- General Fund Public Safety- Increase Capital \$10,000.00 on repairs to gate around North parking lot at the Police Station.
- General Fund Public Safety Increase Capital \$10,000.00 for purchase of portable light tower.
- General Fund Public Safety Increase Operations \$110,000.00 for essential items due to an expanding workforce and obsolete equipment.
- General Fund -- Streets Increase Capital \$27,000.00 for a new engine for street sweeper.
- General Fund Library Increase Revenue & Operations \$1,803.85 for Grant-In-Aid that was awarded higher than anticipated.
- General Fund Community Development Increase Revenue & Operations \$50,000.00 for State of NM EDD grant for the benefit of Carlsbad MainStreet.
- General Fund N. Mesa Sr. Center Increase Revenue & Capital \$8,400.00 for a private donation for an additional HVAC unit.
- Capital Projects Increase Revenue & Capital for the proceeds from the sale of the Fountain property to be used for construction of the new health facility.
- Airport Improvements Increase Revenue \$976,729.00 & Capital \$995,443.00 for amended Aviation Grant for Taxiway Improvements - \$18,714.00 City match included.
