## 00:01:21 5. CONSIDER APPROVAL OF BUDGET ADJUSTMENT REQUESTS

Mr. Lowe asked Ms. Salcido to present the budget adjustment requests to the Budget Committee.

- General Fund/Library Increase Revenue & Operating by \$10,352.38 for the Library Grant-In-Aid to be used for operational expenditures associated with the delivery of library services.
- General Fund/Parks Increase Capital by \$45,000.00 to replenish funds for the annual park improvements
  project that were borrowed for the HAP art project.
- General Fund/ Public Safety Increase Revenue & Labor by \$376,501.46 to add 5 School Resource Officer (SRO) positions and 1 Sergeant Position (February through June). The City will be reimbursed by the Carlsbad Municipal Schools for the labor cost of these positions.
- General Fund/Public Safety Increase Operating by \$200,000.00 for costs due to the additional training and equipment needed for 4 SRO positions.
- Fire Protection Fund Increase Revenue & Capital by \$299,483.63 for the Department of Homeland Security and Emergency Management grant to be used to purchase 32 Self Contained Breathing Apparatus (SCBA) packs for the fire department.
- Lodgers' Tax Non-Promotional Fund Increase Operating by \$55,000.00 for the fireworks project for a total
  project cost of \$120,000.00 for the recently awarded RFP. The City contribution is \$80,000.00 and the County
  contribution is \$40,000.00.
- Lodgers' Tax Promotional Increase Operating by \$80,000.00 for the Boys & Girls Club Gus Macker Tournament Advertising.
