Mrs. Madrid-Boyea said this seems to be a single family home that has been abandoned, no one is living on the property. She said the Eddy County Assessor's Office has Dari-Lynn Wood listed as the owner and her address is listed as 301 Moore Dr. She said Code Enforcement has been made aware of the property and left cards and correspondence at the property trying to communicate with the registered owner and have been unsuccessful. She said Code Enforcement has re-inspected the property and updated photographs have been handed out. She said Ms. Wood is present to answer any questions.

Councilor Walterscheid asked how long this been going on, Mrs. Madrid-Boyea answered since the fall of 2020, not an exceedingly long time. Councilor Walterscheid asked if Ms. Wood has responded at all, Mrs. Madrid-Boyea stated she is present now to address the Council.

Ms. Dari-Lynn Wood said she was not notified until February 8, 2021. Ms. Wood asked the Council for a 30-day extension to get the property cleaned up. Councilor Walterscheid asked Ms. Wood if she just moved to Carlsbad. Ms. Wood explained she inherited the property, and has 6 cases of break-ins. Ms. Wood stated she has had an ongoing problem of break-ins, she said she fixes one way they are getting in and they find another.

Councilor Walterscheid asked if 30 days would be enough time to clean up the property and if she was planning on living there. Ms. Wood said her son and a friend would be living in the house. Ms Wood explained she will continue to clean up the outside of the property and will fix the inside as she has the money to do so.

Councilor Carter said once the Resolution is passed and advertised she has 30 days to get the property cleaned up. Councilor Rodriguez explained if the property is not rendered safe in 30 days the City will hire a contractor to clean the property and a lien would be placed on the property. He explained the Resolution process to Ms. Wood. He stated if the property was rendered safe within 30 days the Resolution would not be needed.

Ms. Wood asked what the rules for storing firewood are. Mr. Patterson said there are no rules regarding firewood, other than keeping the firewood a safe distance from any structures that could burn. He said there are no specific rules for keeping firewood at

your property. He explained as long as the fire department or code enforcement doesn't see a problem with it being a fire hazard.

Councilor Anaya-Flores said she feels the trees and bushes are a fire hazard and asked if 30 days would be sufficient time for the tree trimming to be complete. Mr. Patterson asked Ms. Wood how soon she could get the trees trimmed. Ms. Wood said her son would be trimming the trees and bushes and that they are trying to get the equipment to do the work.
