1. **ROLL CALL OF VOTING MEMBERS AND DETERMINATION OF QUORUM:**

Meeting was called to order by **Mr. Neighbors**. It was determined there was a quorum.

2. **APPROVAL OF AGENDA:**

Ms. Pinching motioned to approve the agenda. **Ms. Tackett** seconded the motion. The vote was as follows: Yes – Neighbors, Pinching, Tackett, Wiedenmann; No – None.

3. **APPROVAL OF MINUTES FROM REGULAR MEETING:**

Ms. Pinching motioned to approve the minutes from the December 1, 2017 meeting. **Ms. Wiedenmann** seconded the motion. The vote was as follows: Yes - Neighbors, Pinching, Tackett, Wiedenmann; No – None.

4. **DISCUSSION OF CITY ACCESSIBILITY ISSUES:**

Mr. Neighbors informed the board that he had spoken with **Mr. Brown** and asked him if he was still interested in being a member of the Disability Board. **Mr. Brown** let him know that at this time he will not be able to serve on the board.

Mr. Brown also let **Mr. Neighbors** know that he was not pleased with the process it took to get on the board. He said it took about six months before it was finally processed and approved by City Council.

Mr. Neighbors indicated that he will get with the Mayor's office the next time the Board wants to appoint someone that way he can see how it works.

Mr. Neighbors said that at Carlsbad Physical Therapy, the parking block, which is about 3.5' to 4' from the curb, makes the cars stick out too far in the street. He is not sure what will work best, but wants **Mr. Cass** to either move it or take it out completely.

Mr. Neighbors let the board know that the builder for the subdivision on Church St. and Happy Valley Road had put in a request for a variance on sidewalks. The City Administrator denied the variance. **Mr. Neighbors** suggested that all members of the board keep an eye on any new subdivisions to make sure that they are complying with ADA rules and regulations.

5. **ADJOURNMENT:**

With no further discussion, **Mr. Neighbors** motioned to adjourn the meeting. **Ms. Tackett** seconded the motion.
