### 0:00:02 **<u>1.</u>** Roll call of voting members and determination of quorum

Roll was called, confirming the presence of a quorum of board members. The following members were present— Ms. Allery, Mr. Kirby, Ms. Pinching, and Ms. Tackett. Absent— Ms. Boatwright, Mr. Pfeifer, and Ms. McKibben.

0:03:40 2. Approval of Agenda

Ms. Tackett made a motion to approve the Agenda; Ms. Pinching seconded the motion. The vote was as follows: Yes—Ms. Allery, Mr. Kirby, Ms. Pinching, and Ms. Tackett. No—None. Absent—Ms. Boatwright, Mr. Pfeifer, and Ms. McKibben. Abstained—None. The motion carried.

### 0:04:08 3. Approval of Minutes from the Meeting held October 13, 2023

Ms. Pinching made a motion to approve the Minutes; Ms. Tackett seconded the motion. The vote was as follows: Yes— Ms. Allery, Mr. Kirby, Ms. Pinching, and Ms. Tackett. No—None. Absent— Ms. Boatwright, Mr. Pfeifer, and Ms. McKibben. Abstained—None. The motion carried.

# 0:06:50 <u>4.</u> Presentation from the City of Carlsbad Building Inspector regarding accessibility-building codes

**Mr. Sullivan** inquired about what questions the board had that they would like answered. **Ms. Allery** asked what the requirements are regarding accessibility in residential housing. **Mr. Sullivan** explained

there is currently not a building code that would force a developer to comply with Accessibility requirements as far as residential housing. He mentioned he had a brief discussion with a local developer. The developer explained that homes are built to order. Mr. Sullivan also mentioned that a developer is not likely to build a handicap-accessible home and hold it in the hopes that a disabled person would purchase the home promptly after building. Ms. Allery asked if the city could influence developers to build a certain percentage of the homes in a new subdivision to be ADA-compliant. Mr. Sullivan explains that they cannot require developers to do so because they are built-to-suit. If a disabled person was interested in purchasing a home, a developer could work with the potential buyer to alter the specs to suit the needs of the buyer. Ms. Allery asked where she could find information on what the city does require when building a home. Mr. Sullivan said that he could provide that information at her request. Ms. Blake mentioned she would like to see more purchasing options for disabled persons other than River Bend Retirement Community, which is currently our only designated community for disabled persons. Mr. Kirby mentioned that there is a company out of Albuquerque, Universal Designs, which designs floor plans to fit the needs of most able-bodied and disabled persons. Mr. Sullivan is willing to have a discussion to request an ordinance change to see the request through. Ms. Tackett asked if the city was able to ask that developers offer an ADA-compliant floor plan to all potential buyers regardless of the need, just so that they could be aware there is an option for an unforeseen future. Mr. Patterson asked Mr. Sullivan if there were specific requirements for wall plug heights and counter heights. Mr. Sullivan explains that the electrical code does stipulate receptacle and switch heights and the building code does have different requirements for handicap buildings. He mentions that the codes are different for residential buildings compared to commercial structures. Alterations could be made to the design of a residence, but it is not a mandated rule that residential buildings abide by handicap building codes. Ms. Allery asked if it were possible to request some of our local developers to come and listen to the concerns of the Disability Advisory Board. Mr. Patterson said he would look into it. He asked that the board get a list of questions and requests together beforehand.

**Ms.** Allery asked if there are any plans to have the North Canal Bridge re-striped. **Mr. Patterson** said he would get a timeline. **Mr. Kirby** asked why the area in front of the Museum was blocked off. **Ms. Ortiz** mentioned they are working on the landscape but is not sure what the timeline is for completion. **Ms. Blake** mentions the city needs to stripe multiple speed bumps around town because they are not visible at night.
