<u>00:01:05</u> <u>5. PRESENTATION OF FY2017-2018 4th QUARTER FINANCIAL REPORT - PROMOTIONAL FUND</u>

Ken Britt presented the FY2017-2018 4th Quarter Financial Report. Ken reported that the balance of the Promotional Funds; FY2014-15 \$26K needs to be spent, FY2015-16 \$175K, FY2016-17 \$735K left over, and we have not spent what we got last year of \$1.4 million. It all adds up to an ending cash balance of \$2.3 Million. Dale Balzano had a question about man-camps which are rented by the day, and are these not like a hotel? Many homes are being rented by the night on the website (Air B&B). Do these people have business license, pay gross receipts tax or lodger's tax? Ken Britt advised that he does not know. Dale Balzano said you can easily track the website. Ken Britt added that this is a question that would need to be asked through Catherine Brown to obtain an official response from Attorney General. Dale Balzano said this question was raised before and wants to know if the City has followed up. Ken said the auditor's response was reported to the Board previously. There was continued discussion about the City following up and this topic in general. Ken advised that there is no answer yet and that this has been brought up to the administration and it will likely take a higher official to make the request to the Attorney General. No more questions about the financials. Dale Balzano motioned to approve the presentation and seconded by Dr. Dara.

00:14:00 9. DISCUSS PROPOSED CHANGES TO THE LODGERS TAX GRANT PROPOSAL PROMOTIONAL APPLICATION

Ken Britt presented this item. Ken said it has been a long time since we have looked at the application and the process related to it. In trying to streamline the process and make it easier to understand with the intent of promotional money in using it out of town and not so much in town. It is important to have advertising in town because visitors will drive into town and pick up a newspaper or listen to the local radio stations, but we see a gamete of requests for advertising in town. The Board has questioned this in the past. The suggested changes are for consideration by the Board to help provide limits so that applicants can have similar amount in support of local advertising. The Board can decide how much they want to make it. Ken proceeded to explain the recommended changes to the application. Neil Wiggins and other Board members discussed in detail and decided to change the specific cost and replace with a guideline and range. Before closing this item, Dale Balzano asked Ken Britt how we were going to spend the money. Ken Britt advised that staff would come back to the Board with recommendations from the City. A strategic approach is a worthwhile idea to address this issue. Dr. Dara suggested we look into how we can get with other cities and see what and how they are doing it to spend their monies. Jay Jenkins provided additional comments in regards to the County working with Roswell and how to make connecting flights at the airport. In Artesia they do not have the same struggles but the action happening is here in Carlsbad. Also suggested was improving transportation services (buses & taxi services) and adding more flights. It is a growth opportunity for car rental businesses. Airport business is growing. Dale Balzano asked whether LTAB can subsidize this opportunity. Ken Britt will research the statues. No further discussion. No vote required.
