## 5. PRESENTATION OF FY2023-2024 2<sup>ND</sup> QUARTER FINANCIAL REPORT – PROMOTIONAL FUND

Ms. Angie Barrios-Testa presented the FY2023-2024 2<sup>nd</sup> Quarter Financial Reports – Promotional Fund. Ms. Barrios-Testa stated that the fund is doing well. The City is on track by spending its FY21 and FY22 and is well on the way to spending the FY23 funding. The City has two years to spend down the funds received. During this quarter the revenue is at 95% of the revenue budget. Finance continues to monitor the expenditures and no issues have been reported. Ms. Barrios-Testa advised that the annual Lodgers' Tax request process is scheduled for the March Lodgers' Tax Advisory Board meeting. This helps the City with budgeting for the next fiscal year. Members were concerned that the December revenue was low and Mr. Balzano asked whether the City is receiving Lodgers' Tax revenue from the temporary housing

and Airbnb establishments. Ms. Barrios-Testa and Ms. Jessica Ponce responded in the affirmative. Ms. Barrios-Testa advised that the City is working on the possibility of bringing in a consultant who would handle the collection of Lodgers' Tax to make sure establishments remain compliant. Members asked if there was information on what businesses are compliant. Ms. Ponce advised that specific information was confidential and could not be shared. Mr. Patel both agreed that it would be helpful to have a breakdown of how much is collected from hotels and other establishments. No further discussion.
