### 6. CONSIDER APPROVAL OF THE REQUEST FOR FUNDING FROM TAMMY NEAL FOR THE YUCCA BLOSSOM TRADE DAYS EVENT

Ms. Tammy Neel presented the request for \$7,000 in funds for the Yucca Blossom Trade Days Event. Ms. Neel stated that vendors come from El Paso, Ruidoso, Alamogordo, and as far as Amarillo, and each vendor pays for their booth. Ms. Neel stated that the total budget for the event is actually \$15,000 and not \$7,000 but she is only requesting some of the items because she wants to be self-sustaining. She hopes not to rely on Lodgers' Tax in the future. Ms. Neel stated that the events are free to the public but they accept donations that go to a family in need. During the Artesia event, \$7,300 was collected for a family in Carlsbad. Ms. Neel is now bringing in eight shows per year in Ruidoso, Lovington, Roswell, Artesia, and Carlsbad, and she is a coordinator for Jal. Ms. Neel walked during the event collecting visitor information, at the last event there were 3,700. The upcoming event will be held at Walter Gerrell Performance Arts Center, which is large enough to hold 60 booths, and only two booths are left unfilled. ## 7. CONSIDER APPROVAL FOR FUNDING FROM NEW BEGINNINGS CHURCH OF GOD FOR THE GRACE AND POWER WOMEN'S CONFERENCE

Ms. Patricia Calderon and Pastor Crystal Mullins presented the request for \$3,300 for the Grace and Power Women's Conference. Ms. Calderon stated that this is the sixth event but their first time requesting Lodgers' Tax due to cost increases for the venue and other expenses since COVID. This event focuses on helping women and young women, and they are seeing an interest in younger girls in the 10-year-old range attending. Ms. Calderon stated that approximately 40% are from out of town, mostly from Texas. Dr. Dara asked if it was acceptable for a church to request funds. Ms. Barrios-Testa stated that other similar organizations have been funded in the past. Ms. Lickliter asked if the City of Carlsbad attorney reviews this type of request. Ms. Barrios-Testa responded that this has been considered in the past and found no rule that prohibits allowing Lodgers' Tax for such events because the goal is to bring tourists and visitors to stay in Carlsbad for a variety of events. Ms. Barrios-Testa asked Ms. Calderon how many days was the event scheduled. Ms. Calderon confirmed that this is a three-day event. The motion was made to approve the request by Elizabeth Lickliter and seconded by Amit Bhakta.
