PARKS AND RECREATION ADVISORY BOARD

An ordinance creating the city of Carlsbad Parks, Trails and Recreation Advisory Board; Authorizing the appointment of members; setting the terms and conditions of office, frequency of meetings; duties of the board; and creation of a secretary

NOW THEREFORE, BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF CARLSBAD, EDDY COUNTY, NEW MEXICO, THAT:

1. Creation.

There is hereby created a board to be known as the City of Carlsbad Parks and Recreation Advisory Board.

2. Appointment of members.

The board shall consist of seven members. The members shall be appointed by the mayor, with the consent and approval of the city council, from the residents of the city. Provided that the mayor may appoint one member of the board who does not reside within the city, but who resides in the county. The board may submit to the mayor a list of recommended appointees for the board, which list shall be only advisory in nature. The board shall serve without compensation. The board shall annually elect one of their members as chairperson and one as vice-chairperson. The mayor and the city administrator shall be ex-officio members of the board but shall have no vote in any of the proceedings.

3. Term of office.

The term of office for the members shall be four years beginning on July 1st of the year of appointment and ending four years later, except that the initial board shall be appointed for staggered terms. Thereafter, all appointments to vacancies on the board shall be for the unexpired term of the member leaving the board. Vacancies on the board occurring by reason of death, resignation, removal from the city or removal from the board for cause shall be filled as provided for original appointments to the board. No member may serve more than two consecutive full terms. Former members may be eligible to serve again after one year absence from the board.

- 4. Meetings. The board shall meet once a month and at such other times as may seem to them fit and proper.
- 5. Removal of board member.
- (A) Reasons for removal include: Absences per City Ordinance No. 2012-13
- (B) Any board member, who shall, by his or her conduct, be subject to removal for cause shall be entitled to a hearing before the city council and is entitled to representation at such hearing and shall be removed if a majority of all members of the city council find that cause exists for removal of such member.

6. Filling of Vacancies.

When vacancies occur, the board shall establish qualifications for, advertise for the replacement of, interview applicants for, and recommend to the mayor and city council the appointment of a park superintendent.

7. Duties.

(a) The board shall have the power to promulgate rules and regulations for the operation, management, care, and custody of all parks, trails and recreation facilities owned or operated by the city, subject to the approval of the city council, except the Carlsbad Civic Center, the Pecos River Village Conference Center, the Lake Carlsbad Municipal Golf Course, the city's sports fields and complexes, the Carlsbad Water Park and the Riverwalk Recreation Center, subject to the approval of the city council.

All rules and regulations of the board shall be kept in the office of the city clerk and shall be open to public inspection during regular business hours. The rules and regulations regarding public use shall be posted in a conspicuous place at each facility to which the rule or rules apply.

- (b) When vacancies occur, the board shall establish qualifications for, advertise for the replacement of, interview applicants for, and recommend to the mayor and city council the appointment of a park superintendent. Recreation is an activity of leisure, leisure being discretionary time. The "need to do something for recreation" is an essential element of human biology and psychology. Recreational activities are often done for enjoyment, amusement, or pleasure and are considered to be "fun". Parks are defined as open, "green" spaces which allow access and use by the public for the purposes of rest, play, recreation, enjoyment and assembly. Trails are defined as off road areas designated for the purpose of public, non-motorized, single or multi-use pathways.
 - 8. Secretary. The parks superintendent shall be the secretary of the board and shall faithfully keep the minutes of the meetings of the board and all other correspondence of the board but shall have no vote in any of the proceedings.
