She also stated the fifty purchased tables arrived, and are available at the Civic Center. Mr. McKinney gave more details on the fire suppression progress. With no further updates from the Director Mr. McKinney provided the Manager's updates.

- 5 MANAGER'S REPORT The Shade will be hosting an event in the Annex in April, and the Hollywood Action Show will also be hosting their event soon. Mr. McKinney stated the weekends are mostly full, and they are starting to book out during the week as well. He mentioned they are already working on the Haunted House that will take place in October. They are also working on Hawg Fest. There are around 14 bands already booked for the event, and many bike groups have contacted him. Mr. McKinney also gave a brief synopsis of the discussion from the Hawg Fest meeting with City Administration and the Fire Department. There will be a medical tent set up, and there will be support from the police and fire departments.
