

NOTICE OF DETERMINATION for EMERGENCY PROCUREMENT

5/8/23

The City is making the determination to proceed with this purchase as an Emergency Procurement as defined in (Section 1.4.1.58-64) of the New Mexico State Procurement Code.

1.4.1.59 DEFINITION OF EMERGENCY CONDITIONS: An emergency condition is a situation which creates a threat to <u>public health</u>, <u>welfare</u>, <u>safety or property</u> such as may arise by reason of floods, epidemics, riots, equipment failures or similar events. The existence of the emergency condition creates an immediate and serious need for services, construction or items of tangible personal property that cannot be met through normal procurement methods and the lack of which would seriously threaten:

A. the functioning of government;

B. the preservation or protection of property; or

C. the health or safety of any person.

The CPO opinion is that the emergency procurement is justified by meeting condition A. of Section 1.4.1.59.

Description of Emergency Condition(s):

On May 8, 2023, the City of Carlsbad discovered that a 16 inch water supply line that feeds a 3 million gallon water reservoir in Carlsbad from our Double Eagle water well field had developed a major leak. Due to this leak, the line has to be shut down until repaired in order to prevent a major loss to the City water supply. In addition, this leak, until repaired, will greatly reduce the water supply to City residents and businesses.

The City is able to secure the necessary parts and equipment to make these repairs from two different vendors:

Benmark Supply Company \$4,869.20

The Chief Procurement Officer looked into alternate means of procurement, including possible contracts with CES and State of New Mexico Pricing Agreements. However, this was not an option, because the vendor did not have any existing cooperative contracts for this service.
