

NOTICE OF DETERMINATION for SOLE SOURCE/EMERGENCY PROCUREMENT

7/30/19

The City is making the determination to proceed with this purchase as an Emergency/Sole Source Procurement as defined in (Section 1.4.1.58-64) of the New Mexico State Procurement Code.

1.4.1.59 DEFINITION OF EMERGENCY CONDITIONS: An emergency condition is a situation which creates a threat to <u>public health</u>, <u>welfare</u>, <u>safety or property</u> such as may arise by reason of floods, epidemics, riots, equipment failures or similar events. The existence of the emergency condition creates an immediate and serious need for services, construction or items of tangible personal property that cannot be met through normal procurement methods and the lack of which would seriously threaten:

A. the functioning of government;

- B. the preservation or protection of property; or
- C. the health or safety of any person.

The CPO opinion is that the emergency procurement is justified by meeting both condition A and C of Section 1.4.1.59.

- A. The City is the sole provider of water for the citizens of Carlsbad. Failure to provide water as a public utility provider would affect the government's ability to function in its duty to the citizens.
- C. The citizens of Carlsbad require water for public health and welfare.

<u>Description of Emergency Condition(s)</u>: The City is required by the State of New Mexico to report data regarding water usage. The City utilizes equipment and software manufactured by In-Situ Inc. and only these products are compatible with our existing equipment and software.

Currently, our transducer is non-functioning and needs to be replaced as soon as possible. Due to the issue with the transducer, we are currently unable to send and/or report the necessary data to the State in order to make determinations regarding surges in water usage and potential need for water rationing procedures.

Because the amount of equipment needed is above our small purchase threshold amount of \$2,500, and we cannot obtain quotes from other sources, our only option is to purchase the needed equipment from In-Situ.

The purchase qualifies as a sole source purchase, but we currently do not have a sole source determination in place. Waiting the required 30 days posting requirement, including the 15 day protest period is not possible due to the urgency of the reporting requirements. In order to be compliant with State regulations, we must proceed with the purchase as soon as possible.

The City has posted a sole source determination notice for In-Situ Inc., which will address any future needs for services to be performed by this vendor.
