We have searched for a wheelchair lift solution to assist the handicapped in loading onto our pontoon boats at the Pecos River during our Christmas on the Pecos Event. This equipment will allow passenger to enter boats from the floating bridge along the river. There were other options for lifts that were too heavy to connect to the bridge without causing potential damage to the bridge and also relied heavily on hydraulics. This is the only solution that we found that was light weight and did not rely on hydraulics or batteries which would require constant upkeep and could potentially create a hazardous condition on the bridge.
